Internet access with up to **10 Mbit/s** downstream and **5 Mbit/s** upstream incl. Wi-Fi access point & 6 port switch and flatrate.\* → per access 680,00 €\*\*

Internet access with up to **50 Mbit/s** downstream and **25 Mbit/s** upstream incl. Wi-Fi access point & 6 port switch and flatrate.\* → per access 800,00 €\*\*

Internet access with up to **100 Mbit/s** downstream and **50 Mbit/s** upstream incl. Wi-Fi access point & 6 port switch and flatrate.\* → per access 1700,00 €\*\*

Internet access with up to **200 Mbit/s** downstream and **200 Mbit/s** upstream incl. Wi-Fi access point & 12 port switch and flatrate.\* → Only on request.

All IP network connections include the transfer via Ethernet plug (no PoE), 6 port switch & 1x WLAN access point. (Larger switches only possible on request)

A timely execution of the assembly work on our part can only be guaranteed if your Order received no later than 6 weeks before the start of assembly. For orders after this time depending on the effort, there will be additional costs. These will be billed to the exhibitor. Surcharges after the order deadline:  
20% from 6 weeks before the start of the event, 35% from the start of set-up, if still possible.

**General information on internet connections at Messe Kassel**

In order to ensure our service quality and customer satisfaction, is to hand over the ordered Telecommunication connections require the presence of an authorized representative of the exhibitor.

The installation and configuration of additional equipment and software brought by the customer is not included.

Real Audio GmbH can only provide the products and services offered to the extent that the technical availability at the required location.

If telecommunications connections are ordered on time, i. H. at least six weeks before start of construction, the timely provision of the service takes place without additional costs.

On the other hand, complaints about the execution of the commissioned services must be made on the respective day in the service

Messe Kassel GmbH office or in writing to Real Audio GmbH. Subsequent complaints are excluded. Proven complaints oblige to rectification. A reduction of Payment or release from the contract is not possible.

## **Terminals**

Rented devices will be distributed by us on the last set-up day and put into operation for you. Should you need the device earlier, you can pick it up from our exhibition center and then pick it up yourself. We assume no liability for any damage incurred.

We will also pick up the devices that have been handed out from your stand on the last day of the trade fair. If you want to return the devices earlier, you can store them in our exhibition warehouse (after consultation). Please submit. Please make sure to return the end devices completely.

Defective hardware will of course be replaced. In the event of repairs, we reserve the right to however, to deliver equivalent devices.

All end devices are rental items from Real Audio GmbH and are available on loan. It is asked that you treat it with care and use it as intended.

The loan is at the risk of the customer. The customer is responsible for the proper storage and responsible for securing the devices.

If end devices are missing or incomplete, the respective new price plus one processing fee charged.

For the WLAN provided by our router in the 2.4 GHz and 5 GHz range, at the stand boundary reaches a maximum of 80 dBm. Neither availability nor bandwidth can be guaranteed. That hangs in individual factors that we cannot influence, such as interference frequencies from other devices, certain stand constructions, a high number of WLAN networks or WLAN users in your area. One stand cabling is not included. DSL access is available one day before the start of the trade fair. An earlier connection is possible on request subject to availability. If you want to operate your own access points, do so these must be registered using the "Exhibitor's own WLAN network" form. The processing of the order is only possible with a plan!
